7:11 pm. 12 Decolores Drive- Scott and Stephanie Galloway- owners; reconsideration to add a shower in finished basement.

Mr. & Mrs. Galloway have submitted photos of the finished area along with a letter.

The board is requesting staff to investigate whether or not other units in the complex have been permitted to add a full bathroom in the basement.

TK: Motion to continue the request for 12 Decolores Drive until the staff can confirm the existence of other units with full bathrooms in the basement. Second MB vote 4-0

7:30 pm. 298 Boston Post Road Ralph and Elaine Wegener- owners- request to disconnect from Town Sewer.

Staff has met with Mr. & Mrs. Wegener and reviewed the septic system that was abandoned to connect to the town sewer. The site has been contaminated from previous activities, and continue to be evaluated. There was a discussion that if the property were disconnected from the town sewer could it be connected to an existing system or should it meet new construction standards. Title 5 regulations require that if you are able to connect to a Town Sewer to do so, and avoid leaching to the ground. After a review of the site and space available, it doesn't appear to Staff that the Wegeners could have an engineer design for New Construction. DEP has replied to staff request regarding whether the change would require DEP approval or if the decision could be made at Staff/Board level.

The owner of the Dry Cleaners has also come with the Wegeners to discuss the amount of water that is being used and the fees that are being charged.
