She has more than 25 years of experience guiding financial turnarounds, joint venture negotiations, mergers/acquisitions and commercial real estate financing. She has a proven track record in a range of industries, including education, travel, luxury textiles, government consulting and real estate finance and construction. During a three-year period, Reinhardt oversaw the development and establishment of two comprehensive communities that provided life and job skill training and counseling for drug and alcohol addiction. In addition, she was instrumental in developing the infrastructure for homeless families in Cambridge and transitional families in Detroit.

Reinhardt holds a Master's degree in Public Administration from the John F. Kennedy School of Government at Harvard University and a Bachelor's degree in Economics from the University of Mary Washington. She is on the board of Package Machinery, Inc. and Fortnight Inc. In the community of Wayland, MA where she lives with her husband and two children, she is very active in First Parish where she is on the Finance Committee and a Trustee of the church.

Dear Mr. Benjamin:

Please be advised that your application for certification of The Wayland Winter Farmers' Market, January 29, 2011 to March 12, 2011 from 10:00 am -2:00 pm as an agricultural event pursuant to M.G.L. c. 138, Section 15F has been approved. A copy of this letter has been sent to the event management.

Please remember that, upon certification of an agricultural event by MDAR, the farm-winery must submit a copy of the approved application to the local licensing authority along with the application for obtaining a special license from the city or town in which the event will be held. Upon issuance of a special license, the winery should confirm that a copy of the special license was sent by the local licensing authority to the Alcoholic Beverages Control Commission (ABCC) at least seven (7) days prior to the event
