

ARTICLE 0: APPROPRIATE FUNDS FOR DESIGN, CONSTRUCTION DOCUMENTS

AND BIDDING FOR A PROPOSED COUNCIL ON AGING/ COMMUNITY CENTER AT WAYLAND TOWN CENTER

Sponsored by: Board of Selectmen and Council on Aging/Community Center Advisory Committee Estimated Cost: \$425,000.

To determine whether the Town will vote to appropriate a sum of money to be expended under the direction of the Board of Selectmen for the purpose of preparing Bid Documents and obtaining bids for a Council on Aging/Community Center building on the "municipal pad," the parcels of land located on and off Boston Post Road (Route 20) and Andrew Avenue in Wayland Massachusetts shown as Lot 4-1, Parcel R-20-1, Parcel R-21 and Lot 8-1 on a plan entitled "Plan of Land in Wayland, MA," dated December 12, 2013 prepared by Hancock Associates and recorded with the Middlesex South Registry of Deeds as Plan No. 1008 or 2013, a copy of which plan is on file in the Office of the Town Clerk.

The design scope shall include renovations to the existing building (10,250 SF) on the "municipal pad" and expansion as needed, as well as related site development. The design will accommodate up to 21,000 SF of building area, with engineering confirmation that waste water capacity is available and sufficient for that size building and for the proposed community center use.

No funds allocated under this Article shall be expended until the Town of Wayland acquires control of the 4.16 acre "municipal pad" and achieves satisfactory environmental testing for PCB's as authorized at the November 9, 2015 Special Town Meeting.

In addition, to determine whether such appropriation shall be provided by taxation, by transfer from unappropriated funds, by transfer of funds already appropriated for another purpose, but not by borrowing, in compliance with Massachusetts General Law Chapter 44 or other enabling authority, or otherwise, and to authorize the Town Administrator with the approval by the voters of the Town of Wayland to take any action necessary to carry out this program.

### Cherry:

I have reviewed Mr. Lanza's comments on the OPEB Warrant Article, per your request and have a couple of notes:

- 1) Mr. Lanza believes that amending the existing Wayland Special Act would be completely within the scope of the article that was originally proposed.
- 2) Mr. Lanza's comments and suggested revisions are very minimal. From my read, they simply clarify a number of the points that you originally made.

From the above, I would like to support Jay's comments about proceeding with Article R at the ATM. There is no reason not to. The amended article is within the scope, it will have been well drafted and well reviewed. It should not be controversial. It should not take up very much time on the agenda. You might remember that the main reason we delayed from last fall's STM was because the agenda for the STM was "too full" and that the agenda for the regular ATM "would be fine". We could just keep putting this off and putting it off, but that does not get the goals accomplished. My guess is that the agenda for a fall STM will not have lots of space that will just need to be filled up. It's likely to be very crowded as well.

As you know, the thing that takes time at Town Meetings are ill prepared and ill considered articles. Well drafted and well considered articles do not crowd the agenda.

We need to be making a 7% return on the funds. You should run the numbers with any lesser return if you want visual proof of what a disaster it will be when the bill comes due. I can run them for you if you like. We need to get to the point of having both good investment governance as well as good, public, periodic reporting - not a single one of which is currently in place. We can't start to make progress on good investment governance without having a real trust. When the Town has a real trust, we can make real investment progress. At the same time, Mr. Senchyshyn will have another card to use at the bargaining table to assure the unions that the money will be there. It will strengthen his hand and it should be an offset to some of the other demands which will surely be on the table.

There is no downside to going ahead, so let's go. I cannot be at the meeting on Friday when Article R is scheduled for discussion, but Jay is planning to attend. Can arrangements be made to hear Jay's comments as part of the article discussion?
