Priority 5: Replacement, renovation or modernization of a school facility system. This project will replace the 124,000 s.f. EPDM Roofing system on the entire building, and further, more specifically acknowledge that by submitting this statement of interest, the Massachusetts School Building Authority in no way guarantees the acceptance or approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the Town of Wayland to filing an application for funding with the Massachusetts School Building Authority.
