A3. Discussion on Any Matters Related to Special Town Meeting Warrant Articles The Board reviewed updates related to Special Town Meeting articles. In regard to Article 1, "Adopt Bylaw re: Clearing, Grading and Protection of Specimen Trees," F. Turkington reported on the collaboration between petitioners and the Planning Board to defer the proposed tree-clearing bylaw to a committee to work to address legal and substantive issues with a commitment to present a revised article to Annual Town Meeting in April 2013. J. Nolan moved, seconded by S. Correia, that the Board recommend for approval to citizens at Special Town Meeting the proposed motion referring the tree-clearing bylaw to a committee for adjustment and submission to the 2013 Annual Town Meeting. The Board discussed its 2-2 vote on Article 5, "Adopt Bylaw: Funding OPEB Through an Individual Warrant Article," from September 27, in which a motion to support Article 5 which would require a separate article to fund OPEB failed. S. Correia and E. Collins reviewed the pro and con arguments and J. Nolan expressed the reasons for his opposition. E. Collins moved, seconded by S. Correia, to recommend Article 5 for approval to citizens at Special Town Meeting. YEA: E. Collins, D. Leard. NAY: J. Bladon, S. Correia, J. Nolan. ABSENT: none. ABSTAIN: none. Motion fails 2-3.
