Senior Member J. Nolan called the meeting of the Board of Selectmen to order at 8:15 a.m. in the Selectmen's Meeting Room.

A1. Executive Session to Discuss Strategy and Negotiations with Respect to Pending Teamsters Local 170 and AFSCME Local 690 Grievance Hearings At 8:15 a.m., S. Correia moved, seconded by J. Nolan, that the Board of Selectmen go into executive session pursuant to Massachusetts General Laws Chapter 30A, Section 21(a)(3) for the purpose of collective bargaining strategy discussions with respect to pending Teamsters Local 170 and AFSCME Local 690 grievance hearings, as a discussion in an open meeting may have a detrimental effect on the Board's position.
