Adopted 5-0) in open session as permitted by Massachusetts General Laws Chapter 30A, Section 21(a)(3) for the purpose of discussing strategy with respect to Twenty Wayland, LLC v. Town of Wayland and Wayland Wastewater Management District Commission as a discussion of these matters in an open meeting may have a detrimental effect on the bargaining or litigating position of the Town.

Discussion: Mark Lanza updated the Board on the appeal of the decision in the lawsuit of Twenty Wayland LLC v. Town of Wayland.

a list of potential negotiating points with Twenty Wayland LLC. The Board reviewed the document. S. Potter discussed the rationale of the Wastewater Management District Commission regarding the percentage of flow and daily discharge allocation to the town center project. C. Karlson asked that all the percentages and figures be codified and defined for the understanding of the Board.
