Adopted 5-0) in open session as permitted by Massachusetts General Laws Chapter 30A, Section 21(a)(6), to discuss the value of real property at 87 Old Connecticut Path, Wayland, commonly known as Mainstone. The Chair declares that a public discussion of these matters may have a detrimental effect on the bargaining or negotiating position of the Town.

Discussion: C. Karlson reported on attending an executive session of the Community Preservation Committee (CPC) on September 24, 2015, regarding the acquisition of property at Mainstone Farm. The CPC invited C. Karlson and representatives of the Sudbury Valley Trustees to attend to hear the report of the appraiser hired by CPC to value the Mainstone property and to review the potential conservation restriction. She reported that the owner of the property, the Hamlen family, plans to send a letter of intent to the town with the terms of the proposed sale. She reviewed the results of an appraisal of the property commissioned by the town, which included an appraisal of the property based on its highest and best use. The purchase would potentially be funded with community preservation funds, borrowing against future community preservation funds, funds from the Sudbury Valley Trustees, grant funds and town funds. She said the acquisition will be negotiated by the Conservation Commission with the support of the Board of Selectmen, if requested.
