MEETING MINUTES

Meeting opened at 7:00 PM

Baston announced that the meeting is being recorded.

Baston reviewed the agenda.

Baston asked for public comment – there was none.

Discussion and Potential Board Vote Concerning Irrigation Application Approval Process

Lowery suggested that due to the absence of Abdella and Water Superintendent Millette, discussion be delayed until the next meeting.

<u>Discussion and Potential Board Vote Concerning the Potential Funding of the Repair of the</u> <u>North Cemetery Stone Wall as a CPC Project</u>

Lowery noted that CPC project applications are due on 12/15/17, and that an estimate would be needed as part of the application.

The Board discussed the overall condition of the wall and whether the current condition warrants extensive repairs.

Lowery asked Holder to gather more information regarding the potential repairs and associated costs, for consideration as a CPC project for November Town Meeting.

<u>Discussion Regarding Potential Advanced Metering Infrastructure Water Meter Reading</u> <u>Systems</u>

Lowery discussed a recent meeting with North Reading officials he attended with Tom Abdella and Tom Holder regarding the Advanced Metering Infrastructure (AMI) Meter Reading System employed by the Town of North Reading.

Lowery discussed the RFP and AMI implementation process undertaken by North Reading.

Lowery described North Reading's experience with exploring a connection with MWRA.

Mishara asked if North Reading residents expressed any concern about the health effects of the radio frequencies.

Lowery replied that North Reading did not experience any significant concerns from residents.

Holder urged the Board to consider beginning a public education program prior to seeking approval at Annual Town Meeting.

Discussion Regarding WWMDC & High School Treatment Plant Costs as well as Proposed Waste Water Operations Manager Position

Uday Virkud, member of the Waste Water Management District Commission, appeared before the Board to discuss the proposed Operations Manager position.

Holder described the general role of the proposed position, noting that the position would report to him.

The Board reviewed the Operations and Maintenance Budget Analysis for the Town's Wastewater Systems.
