# **Public Comment**

Cliff Lewis – Called attention to the hemlock blight. Lewis told the boards how the insect attacks and kills the trees. Lewis asked that the Town spray to take care of this problem. Lindeman told the boards that the Town hasn't sprayed for years. Money is needed in the budget to spray trees. A discussion ensued about spraying and replanting trees. Montague mentioned the possibility of using CPC funds for spraying and planting new trees.

Lindeman told the board that he was instructed not to drive the town during the past 5 years looking at the health of trees. Lindeman said that the trees that have come to hearing during the past 5 years were brought to his attention by residents throught service requests. Lindeman said that Ouellette has requested he drive the town checking the health of trees, which he will be doing from here on in.

Lindeman said that tree 1011 is a dangerous tree and it leans towards the roadway.

### **NSTAR PRUNING**

Sarki spoke of other towns that have had issues with NSTAR's pruning. Sarki recommended that the Planning Board put on hold approving NSTAR pruning on Scenic ways. Sarki spoke about the Planning Boards role and how they need a scenic road maintenance plan. Ouellette said that NSTAR had a permit and did a good job pruning on Claypit Hill Road. A discussion ensued about the limits set on NSTAR for Rice Rd. Lindeman spoke of the state law regarding line trimming. Sarkis told the boards that Lexington came up with a tree warden manual which includes line trimming.

Wegerbauer for the DPW board made a motion to approve NSTAR's request to trim as long as they adhere to the 8x8x12 rule, any exception must come before the DPW board.

# **Shade Tree Hearing**

9:45 Mishara opened the Shade Tree Hearing

Mishara, Abdella, Brown, Wegerbaur, Ouellette, Lindeman and Gorham are present

A discussion ensued about old trees at Old Stonebridge. Lindeman said he believes that is under the jurisdiction of Mass Highway.

Handed a document to Ouellette from Linda Segal for Public Comment since she was unable to make the meeting.

Lindeman made the recommendation that all of the trees on the shade tree list should come down.

Public Comment – George Harris from Holiday Road expressed his concern for tree 1013. Harris said that he realizes that the tree needs to come down because its in bad shape, but said that in the past the tree has been good shade / shelter for the kids waiting for the bus. Harris would like to see a tree replanted at the spot. Lindeman said that he intends to plant 2 -3 trees in the grassy area. A discussion ensued about applying for CPC funds to plant \$100,000.00 worth of trees.

A discussion ensued about the trees that came down in the microburst on June 24<sup>th</sup>.

A discussion ensued about inventorying trees and identifying potentially hazardous trees.

A discussion ensued regarding cutting scrub before a tree is 1 ½" in diameter.

Wegerbauer made a motion to approve the removal of trees 1015, 1016, 1017, 1018, 1019, 1020, 1021, 1022, 1023, 1024, 1025, 1026 at the expense of Brendon Properties 2<sup>nd</sup> Mishara
