Public Comment

Linda Segal – hasn't received an answer on the wireless meters. Segal asked which meter will be used. Ouellette explained there is a pit and a wall meter. Discussion about the difference in meters. Segal said that she was told that the functionality is different. Segal said she wants to make sure that privacy is secured. Lowery explained the differences between the two meters. Wegerbauer said that one transmits 6x daily vs 4x daily.

Understands functionality is different. Can't say what it is, but was told. Not technical. Wants to secure privacy.

Lowery explained some of the differences. Signal sent is the same strength etc. Linda how to assure the public? Mw it is 6x a day vs 4x day. Linda concerned for voters.

Bogren Road Issues

Mark Newman of 12 Bogren Rd. is present

Newman expressed his concern with the condition of Bogren Road. Bogren Road is a dead end road with 6 houses. Newman pointed out that this road poses hazards for children. Newman said that thank you to Ouellette the road had bean patched. Newman said the road is now degrading and the condition is poor. Newman said the road should be paved. Doug Alongi neightbor said that Ouellette did a great job fixing the road last year. The road has deteriorated since then. A lot of kids play in the road at any given time. Discussion about patching. Ouellette explained the proper way to fix the road. Discussion about the poor condition of the road. Ouellette said that he will go take a look at the road. Discussion about the place in the queue to repair the road. The neighbors said they would like an idea of the timeframe. Ouellette said to contact him, he will chieck the road out later this week. Brown will put it on a future agenda. Discussion about how residents will access their homes while the work is being done.

Proposed River Road DPW Facility location – meet with neighbors

Bill Davlin, Tracy Davlin and Paul Doerr were present representing the residents of River Road.

Brown thanked everyone for coming. Brown acknowledged that their has been alot of discussion. Brown asked the neighbors to give the Board an update.

Discussion about Article 10. Davlin said that he wants to see a restriction to access River Road except for in the case of an emergency. Davlin said that they are trying to amend Article 11 to restrict access from River road except in emergency. Paul Doerr said that they are currently working on the language restricting River Road access to emegencies only. Discussion about snowstorms / emergency. Doerr spoke of the uniqueness of River Road. Discussion about how it should be decided if there is an emergency. Wegerbauer asked about major snow storms which only happen about 10 times a year and how to determine that they are emergencies. Discussion. Discussion about clearing the town quickly when a snow storm occurs. Wegerbauer expressed his concern with the cost associated with only using the access road. Lowery said that he is less concerned with the cost then how quickly the town can be cleared following a snowstorm. Lowery agreed that River Road is a wonderful area however the Board has a responsibility to protect the whole town. Discussion about snow emergencies. Doerr said that its OK when the Governor calls a State of Emergency to use the River Road access. Davlin said he is willing to figure out a language that will work for everyone. Discussion about wether or not a Snow storm would qualify as an emergency. Discussion about the 18 Wheelers that haul the salt in. Doerr said that although it doesn't happen a lot, when the salt trucks come there is a lot of noise and they shake the road. It is a bit disruptive but they have tolerated it. Mishara spoke of significatn snow event. Mishara said he does not want to be negligent when it comes to snow removal. Discussion about a compromise. Discussion about the major occurances over the last 3 years. Discussion about emergency response and what denotes an emergency. Discussion.

Access to River Road restriction – use only for Town wide emergency deteremined by Fire or Police and/ or medical when deemed appropriate by Police or Fire Departments emergency services including snows emergencies. Discussion about discreet access. Mishara said that he doesn't want to compromise public safety.

Wegerbauer made a motion that it shall be the sense of the Board of Puablic Works that the Town agree to limit access to River road to be used for Fire, Police or Medical emergencies at the site or to reposndt to Town wide emergencies and or snow emergencies as declared by the Police or Fire Chief. The entrance from River Road be discreet and well screened and subject to electronic gate device.
