- 3. EDC Priorities
 - a. Route 20 Septage/DPW Site proposal
 - i. Feedback to date continues to be positive. Senior Housing Focus Group scheduled for Wednesday, March 14 at 7:00, COA in the Town Building. Town Warrant Public Meeting/Q&A Session scheduled for Wednesday, March 21 at 7:00 in the Town Building. Goal of both meetings is to continue outreach and gathering of input from potential users and other town residents.
 - ii. Following up on Conservation Commission query, historic aerials confirmed most if not all land to be used on site has been disturbed prior to 1970's.
 - iii. Draft and warrant article progress and language revisions reviewed. Becky to make discussed changes and submit to Fin Comm.
 - iv. Discussed issuance of first phase of RFP's- market study, environmental review, septic perks
 - v. Article/announcements for Town Crier on both the Senior Housing Focus Group and Public Meeting/Q&A Session to be written and reviewed by the members.
 - vi. Sarkis to review criteria for DLTA (District Local Technical Assistance) for possible Sustainable Communities Grant for Septage/DPW site design efforts (maximum likely in range of \$40-50K). Due by Friday, February 17. Winners of funds to be announced the end of March.
