Prospective Members: Kamal Namou (approved by BOS but not sworn in yet), Andy Oppenheim (approved by BOS but not sworn in yet)

Guests: Sarkis Sarkisian

Frank called the meeting to order at 8:06 a.m. in the Planning Office at Town Building.

Public Comment:

Sarkis

- The owner of 70 Main St. would like to do something creative with the building and is seeking any available funds to help
- A 12 acre parcel could be acquired by the town by the end of the year
- There is a trail through it that will connect to Cow Commons
- Municipal Parcel: Cherry Karlson will host a town meeting regarding the parcel
- 20 Wayland will potentially gift Town Green to Wayland; this proposal will go to Town Meeting in November
- Plan for fields at 91 Oxbow got appealed; lawsuit claims Town of Wayland will "be overburdening the field"

Frank

- Provided summary of August 18th meeting with Zurich & National Development
- Sharmeen Dossani attended from Zurich, and David Costello and Erika Clarke attended from National Development
- Zurich/National Development discussed plans to fill the Town Center with new retailers
- Seeking to add a new restaurant and bring in a diverse mix of new retailers that would be attractive to Wayland residents

<u>Fresh Market</u>: (Note agenda items discussed in varied order vs agenda, given several of the topics arose during Public Comment)

- Fresh Market is no longer coming to Wayland; the company is having financial difficulties but is still responsible for the lease
- Fresh Market signed a 15 year lease and is required to make improvements
- Seth discussed that the company is owned by a private equity firm, and grocery stores are afraid of Amazon; Fresh Market has ceased expanding new stores
- Roche Brothers is not interested in the location

- Sarki sent Trader Joes a write-up of location, and he was asked to wait a couple of weeks for a response
- Wegmans opening in Natick (2 floors)
- Be Happy is having some difficulties since Whole Foods closed; there was a suggestion to possibly lease space in the hardware store

<u>Rail Trail</u>: (Note agenda items discussed in varied order vs agenda, given several of the topics arose during Public Comment)

- Construction is still waiting on a signature from the Secretary of Environmental Affairs at the MBTA
- It will probably start in October
- Wayland is applying for another grant with the DCR for the wooden bridge along Route 20 near Russell's

<u>Wayland Business Association</u>: (Note agenda items discussed in varied order vs agenda, given several of the topics arose during Public Comment)

- Dave Larson (Joint Ventures Physical Therapy) is no longer part of the WBA because it is not helping to develop his business
- There are some mixed opinions on whether the WBA should be a social organization for local businesses or more of a business development organizion
- Jim suggested potentially using a mediator to help the group come to an agreement
