Brian Boggia was not available to present on potential for solar PV on WHA properties

Status of solar project installations at the DPW building

- -Ameresco updated their design to take into account the obstructions on the roof
- -Ameresco also updated their lay-out for the location of the inverter to comply with Code

Status of solar project installations at the High School and the Middle School

- -Ameresco and members of the Energy Initiatives Advisory Committee presented the construction plan to Schools on 14 August
- -Work is expected to start in the fall and continue through April 2016
- -Middle School construction will be executed in two phases. The first phase will include trenching, foundations, and underground wiring. The second phase will include steel erection and canopy installation. The second phase work is notionally planned to take place during school holidays, weekends, and nights.
- -High School work will be executed in 2 phases. Phase 1 will be conducted in 7-phases with the parking lot divided into 7 sections. Ameresco will work to shut down each of the 7 sections one at a time to minimize total disruption. Phase II will involve construction of the canopies and will be completed during the winter or spring school break, pending discussions with schools.
- -Ameresco is tasked with presenting a revised schedule for the work at both schools
