1. Public Comment: None

2. Introduction of members present of the Historical Society, Historic District Commission, and the Historical Commission

3. Discussion of possible Demolition Delay Bylaw and review of bylaws in neighboring towns:

Joint discussion as to length of delay, age of buildings covered (50 years, 75 years, 100 years?), length of time for delay (3 months to one year/one year holds up in court), all demo delay bylaws are "home rule"-not legislative, question as to modern architecture that could be historically significant, proposed use of a better/less offending name, need to start educating public about interesting/historic buildings in town (past and present), could do as part of Wayland 375, possible ideas to include such as incentives and relocation. WHC to come up with a proposal.

4. Discussion of Railroad Bike Trail and Railroad Interpretive Site:

Joint discussion. Gretchen Schuler stated that the \$250,000 from Town Center developer must be used within two years of issuance of permit for Phase II. This has not happened yet. Sarki is working with Iron Horse re: stone dust trail. Elisa stated that we want to save/preserve whole rail. HDC (Gretchen) had a different understanding. Discussion re: trail being beside the rails/question of safety issues/artifacts need to be safeguarded. HDC only has jurisdiction over a small section. Suggested that Rick Conard and Sarki talk to discuss these specifics, as Rick is our railroad expert.

5. Other projects for joint discussion: (Sheila)

DCR is going to re-pave overflow parking for Cochituate State Park. There is a registered site near that area. Conservation Comm stated there should be fencing around area with no more than a two foot margin.
