#### **Public Comment**

WHA residents spoke to the WHA Smoking Policy. Residents asked for an elimination of the grandfather clause in the current WHA smoking policy. Smoking health and safety concerns were voiced. The WHA Board thanked the residents for their comments. The WHA Board would like to hear for all sides on the issue before making a decision. #### **Executive Director Report**

The Board discussed the Executive Director Report, budget comparatives, Administrator's report, Family Self-Sufficiency Program, Ready to Buy Program, PILOT payment to the Town, Oxbow Meadows monitoring, CVA masonry repair.

### Other Business

CVA Residents raised the following issues regarding the Cochituate Village Apartments: inadequate parking lot signage; tenant using window as entrance is creating a possible security concern; pets on leashes blocking Shawmut Avenue entrance; a tenant with multiple pets in violation of the WHA Pet Policy, a tenant flushes kitty litter down the toilet; the WHA should adhere to the flag code and the flag should not be lowered when a tenant dies; the community room refrigerator and closet should not be locked; kitchens should be remodeled; the hallway rugs should be replaced. B. Boggia will look into these items.

#### Water Utility

The Board reviewed the scattered sites water bills. The Board is concerned with high water bills. The Board considered charging water bills directly to tenants. The Board decided on additional letters to tenants with high water bills, charging tenants for excess usage, and shutting off outside spigots.

## Performance Improvement Plan

The Board deferred the Executive Director's performance review until all of the Board members delivered their responses to M. Antes. The Board reviewed administrative pay increases. C. Raskin moved to increase administrative staff increases by a total budget line item increase of 3% to be distributed among staff by merit effective July 1, 2010. Vote: 3-0-0 (2010.41)
