Chairman Antes convened the meeting at 7:00 P.M.

Public Comment

R. Soulia presented M. Antes with a donation certificate for the Habitat For Humanity project in Wayland. The Board expressed thanks to the BPTC for their contribution. K. Dodge asked if it was true that \$100,000 was being spent for parking lot renovations were being done at CVA and not Bent Park where it is needed most. B. Boggia confirmed that a contract estimated at \$100,000 for the renovation to the CVA walkways and entrance was currently out to bid. The money come from a HUD Capital Improvement Fund. Because Bent Park was recently moved from the state to federal portfolio, Bent Park is not eligible to access those funds for five years.

Bent Park Tenant Council (BPTC)

K. Dodge presented the changes to the BPTC draft by-laws and budget as recommended by the WHA Board. There was lengthy discussion about the proposed stipends for BPTC Directors. The WHA Commissioners expressed preference for paying for conferences and training that would benefit the entire community verses paying stipends to a few members. The WHA Board asked the BPTC to submit a detailed budget that specifies which conferences they wish to attend. The BPRC Directors will delete the by-law references to stipends from Article #2.6, remove loans in Article #9, and change Article #6.4 to require a Treasurer's report on the financial status at each tenant meeting. The WHA Board also suggested staggered terms and requiring a quorum of 10% of all tenants in order to call a meeting. K. Goodwin moved to accept the By-Laws of the Bent Park Tenant Council as amended and was seconded by R. Ashton. Vote: 5-0-0 (2012.17) The WHA will write a confirmatory letter of recognition of the BPTC. The BPTC will submit a proposed budget at the next WHA Board meeting.

Bill Warrant

The Board reviewed the Bill Warrant. S. Weinstein moved to approve the Bill Warrant for April 2012 and was seconded by K. Goodwin. Vote: 5-0-0 (2012.18)

Executive Director's Report

The Board reviewed the Executive Director's report including budget comparatives, replacement of the Bent Park rail fence, Section Eight Management Assessment score, and maintenance. The Board instructed B. Boggia to get some quotes to clean the Bent Park hallways.

S. Weinstein submitted edits to the Nondiscrimination Policy. S. Weinstein moved to adopt the Nondiscrimination Policy as amended and was seconded by K. Goodwin. Vote: 5-0-0 (2012.19)

Habitat Stonebridge Affordable Housing

M. Antes reported on the fundraising activities of Habitat for Humanity. ON September 9, a fundraiser will be held at Russell's Garden Center. Habitat received \$5,000 from the Bennett Foundation. Habitat is marketing building blocks for Father's Day as a fundraiser.

Other Business

S. Weinstein will investigate the possibility of using CPC funds for the fire sprinkler system at the Cochituate Village Apartments.

The next regular WHA Board meeting was tentatively scheduled for 7:00 PM on June 21, 2012 at Wayland Town Building. B. Boggia raised concerns about the high use of water and the possibility of including water as a utility allowance. The Board discussed alternative methods of encouraging water conservation among WHA tenants. B. Boggia will obtain quotes for replacement of the Bent Park rail fence.
