#### River's Edge

Rebecca Stanizzi from the Wayland Economic Development Committee (EDC) presented a revised proposal for the River's Edge Chapter 40B Development. Ms. Stanizzi was seeking input from the WHA and other Boards on the new proposal. The EDC will be submitting an article for the Spring Town Meeting. The development has been scaled back to 150-190 units with 25% of the units designated as affordable.

M. Antes gave an update of meetings with the Community Preservation Committee and the upcoming Finance Committee consideration of submitting warrant articles for funding of the installation of the CVA fire sprinkler system.

### **Board Goals-Accessory Apartments**

M. Antes and J. Ducharme will meet to work on ways to make the accessory apartment by-law more user friendly as a method to provide more affordable housing.
