Boggia noted that the WHA will be able to reissue unused vouchers. The Board reviewed Section 8 Voucher utilization rates and the upcoming revision of the Section 8 Administrative Plan.

# Chapter 40B

B. Boggia reviewed his memo on Chapter 40 monitoring in Wayland. The Board instructed B. Boggia to make a proposal on behalf of the WHA to Devens Hamlen for property management services for Covered Bridge. M. Antes reported that a recent meeting between the Wayland Housing Partnership and Brookside developer Steven Zieff went very well.

M. Antes reported that Marty Nichols had resigned as the WHA representative from the Wayland Housing Partnership Committee. The Board will recommend an appointment to the Board of Selectmen at the October meeting.
