Review of May 24, 2010 Meeting Minutes:

Review of May 24, 2010 Executive Session Minutes:

NW moved to approve the minutes of the meeting. JE seconded the motion. Four members having voted in the affirmative, the motion passed.

Old Executive Session Minutes

JS noted that there were numerous executive session minutes of the Personnel Board that had not be approved for release. JS reported that he had discussed with Town Counsel an appropriate motion to release the executive session minutes and presented the draft motion to the Board. The members discussed the implication of releasing old minutes and the manner in which executive session minutes are addressed under the new OML.

NW moved to release Personnel Board executive session minutes prior to January 1, 2009 where the release of said minutes is not related to current litigation, where the release of said minutes will not adversely affect the Town's position in collective bargaining negotiations, where the release of said minutes will not adversely affect the Town's position in bargaining with non-union employees or where the release of said minutes does not contain information on an individual's private and protected personal information. JE seconded the motion. Four members having voted in the affirmative, the motion passed.

NW made a motion to move into Executive Session for the purpose of discussing collective bargaining strategy as conducting the business in Open Session will have a detrimental effect on the Board's negotiating position. JE seconded the motion.

Job Description – Finance Assistant, Payroll

The Board reviewed the edits in the job description of the Finance Assistant-Payroll. JS explained that the changes were minor and were intended to incorporate the processing of the School's payroll into the Town's Finance Department. The grade for the position remains the same. The Board discussed the proposed changes. MP suggested an additional edit to the Knowledge, Skills and Abilities section.

MP moved to approve the revised job description for the Finance Assistant-Payroll as edited. JE seconded the motion. Four members having voted in the affirmative, the motion passed.

New Business

JS informed the members that P. Schneider's (PS) appointment to the Board expires on 6/30/10. Members expressed their support and desire for PS to seek reappointment for another term. JS stated that he would pass along the Board's sentiment to PS.

The Board had a discussion regarding the performance evaluation process. Previous Board efforts to address the deficiencies in the evaluation process were raised. Members posed various ideas to improve the evaluation process. The suggestion was made to add the evaluation discussion as an agenda item for a future meeting.
