## Finance Assistant T/C – Starting Wage Rate

JS presented the application of Thomas Rizzo, who has been selected to be the new Finance Assistant in the Treasurer Collector's Office. JS recommended a starting wage rate of C-15, Step 6 based on the candidate's background and experience. The members discussed the candidate.

MP moved to approve a starting wage rate for Thomas Rizzo at C-15, Step 6 of the SEIU wage schedule. PS seconded the motion. Five members having voted in the affirmative, the motion passed.

#### **ATM Preparation**

JS and NM reviewed a number of personnel related questions that had been posed at recent FinCom meetings. In, addition JS reviewed information requests submitted by K. Cook and A. Lewis. JS asked the members if there is specific information that they

would like to have available for Annual Town Meeting. The Board discussed possible reports/data that might be helpful. JS provided draft reports for non-union wages, FTE counts and the response to Lewis' information request.
