FinCom Meeting

JS reviewed his 9/2 meeting with the FinCom regarding COLA's. The FinCom agreed to support an increase in the 3-year COLA being negotiated from 4.0% to 4.5%. The additional .5% would be added to the 3rd year.

Library MOA

Based on the change in the COLA, JS reported that he had reached agreement with the Library Union on a successor 3-year contract. He reviewed the MOA with the Board. JS also reviewed the cost of the agreement. He noted that if the MOA is recommended for approval by the Board, then the union would hold a ratification meeting with the intent of presenting the MOA to the BOS on 9/29. JS stated that he supports the MOA.

Teamsters MOA

In addition to the Library MOA, JS also reported that he reached agreement with the Teamsters on a successor 3-year contract. It also includes the 4.5% COLA. He reviewed the MOA with the Board. JS also reviewed the cost of the agreement. He noted that if the MOA is recommended for approval by the Board, then the union would hold a ratification meeting with the intent of presenting the MOA to the BOS on 9/29. JS stated that he supports the MOA. Having 2 settlements should provide the impetus for additional union settlements.

AFSCME Negotiations

JS reviewed Tentative Agreements to date. JS highlighted items that were still at issue, one being a rearrangement of the 4.5% COLA payout and another being the addition of new relationships under the bereavement clause. The Board would not support a COLA that differed from the FinCom's guidelines, nor was it willing to extend the relationships that qualify for bereavement leave. JS also reported on the union's concern about becoming uncompetitive with other communities if the vacation benefit was reduced. The Board wanted to maintain the proposal to prospectively reduce vacation accrual for new hires.

Police Union Negotiations

Initial proposals had been exchanged. JS reviewed the officer's initial proposals. JS queried the Board on withdrawing from Civil Service. Should the Town offer an incentive for the union's cooperation? Labor Counsel had indicated

JS noted that that was not the approach of most communities thus far. The Board agreed that it prefers to seek the police officers' agreement on withdrawing from Civil Service.

Fire Union Negotiations

JS stated that he had exchanged emails with the president of the Fire union. It appears that the union may finally be ready to resume negotiations.
