## AFSCME Proposal

JS reported that negotiations stalled over the reduction of the maximum vacation accrual. JS stated that AFSCME requested the Board to consider a settlement without the vacation change. DC asked what else the Town might look to in place of the vacation reduction. The Board discussed several options including the re-structuring and re-grading of the IT position. This would facilitate the consolidation of IT services with the School. The Board directed JS to proceed with the IT option.

## **DPW** Structure

JS shared an ongoing discussion at the staff level to look at a consolidation of the Parks and Highway Superintendents positions. The proposal was to set up a temporary consolidation for 1 year at a Grade G9. This would make the temporary position equivalent to the Water Superintendent. Parks Superintendent Mike Lindeman would be offered the opportunity. If the consolidation works, the vacancy might be filled by hiring an Engineer. The idea needs to been vetted with the BOPW. As the Superintendent positions are affiliated with AFSCME, the will be impact bargaining required. The Board was in agreement in approaching the union regarding the change.
