Collective Bargaining

AFSCME/Clerks – JS reported on the last meeting. Little progress had been made. JS made a proposal to the union to remove the position of Finance Asst.-Benefits from the bargaining unit as the incumbent should be involved in crafting health insurance proposals for collective bargaining.

Fire – JS reviewed the 2 draft MOAs that were provided to the firefighters. There are 2 MOAs because the settlement exceeds the 3-year period as provided in M.G.L. Ch. 150E. The union held a membership meeting, but the follow-up meeting with the bargaining team had been cancelled. Members discussed the draft MOA and indicated they would support a settlement comparable to the draft.

Police – JS reviewed the last meeting with the Police. The union stated that under no circumstances would they agree to leave Civil Service. Following a lengthy caucus, the Police offered a package proposal. JS presented the approximate costs of the package. The Board reviewed the Police proposal and projected costs. Members would support the educational proposal, but rejected the proposal for expanded steps.

DPW Water Worker/Equipment Operator Job Description

JS reported that he met with the Teamsters regarding the job description. The final draft has the same duties and responsibilities, but the Minimum Entrance Requirements were adjusted to reflect a more definitive licensing path.

MP moved to authorize JS to complete negotiations on the draft job description for a DPW Water Worker/Equipment Operator. PS seconded the motion. Roll call vote: Roll call vote: Schneider – Aye, Jones – Aye, Cohen – Aye, Peabody – Aye, Green – Aye. 5 members having voted in the affirmative, the motion passed.

AFSCME 1/ Step 2 Grievance
