The Wayland Planning Board met **Tuesday October 16, 2012 at 7:30PM** in the Wayland Town Building, 41 Cochituate Road, Wayland, MA relative to the following agenda items:

- 7:40 Please note: Meeting continued to October 30, 2012. 150 Main Street proposal for a proposed mixed use redevelopment located at 150 Main Street, Wayland MA. The 2.84 acre site is comprised of a 14,000 square feet (SF) restaurant and single family homes. The proposed project consists of a total of 25,080 SF of mixed use commercial development floor space consisting of a 10,880 SF CVS with a drive-through window, a 3,600 SF restaurant, 3,500 SF of retail floor space and 7,100 SF of second floor office space. The former restaurant will be demolished and removed from the site.

C. Sheehan opened the meeting and reviewed the agenda. No Public Comment

S Sarkisian presented the proposed building design. Significant changes from the initial design contained in the MSP included lowering of the second story floor and the location of certain windows and doors. Notably, the entrance on the street-facing, western façade was removed.

After some discussion the Board instructed the Town Planner to request that Twenty Wayland incorporate an entrance on the west façade to facilitate pedestrian flow and improve aesthetics. The Board also noted that an update to the landscape plan is required.

8:00 SPRINT CONTINUATION OF PUBLIC HEARING FOR SITE PLAN APPROVAL

S. Sarkisian reviewed the updated application which includes requirements for fencing, landscaping and drainage.

The Board discussed the requirements for sound emissions. Sprint provided a prospective sound analysis and the Board discussed requiring a follow up analysis within 30 days of activating the equipment.
