A long discussion was held regarding the Conveyance of Land that is proposed to be accepted by the Town of Wayland Conservation Commission. Abutter Stanley Shelton who was present at the meeting was requesting specific uses and requirements regarding the back parcel/strip of land. Open space can be used conservation, agriculture, out recreation, park purposes or some combination of the foregoing.

C. Sheehan was concerned that we would set a bad precedent regarding open space and if it truly was not open to the public.

D. Hill recommended that the following language be placed as a condition in the decision:

The conveyance of the open space parcel to the Conservation Commission shall include the execution of any and all conveyance documents as determined necessary by Town Counsel to ensure the perpetual protection of the open space parcel as open space.

A.Reck requested that we add a condition in the decision regarding the preservation to the existing home.
