Community Input Meeting TOWN OF WAYLAND

Oxbow Meadows Field Development

Wayland residents are invited to attend a public input meeting hosted by staff representing the Recreation Commission. The meeting is being held to update residents and gather input about the proposed rectangular, multi-purpose, natural grass playing field that is proposed to be constructed at the Oxbow Meadows site.

The Oxbow Meadows project proposes constructing a multi-purpose field with the preliminary design beinga natural grass, rectangular playing field 100x300 yards. The layout of the field includes a 20' wide border. The proposed grading of the field surface are slopes 1-2% to drain. The existing ADA accessible crushed stone path and vegetation between the path and property lines will not be disturbed. Irrigation connected to a Town Water source is being considered.

The existing parking for 10 spaces is expanded to include another 10 spaces for a total of 20 parking spaces. Adjacent to the paved parking is an overflow, crushed stone parking area with capacity of 14 spaces.

YOUR OPINION COUNTS!

At the meeting, Marshall Gary (the Town's consultant) will describe the proposed field in more detail and hope to gather thoughts and feedback on the preliminary design. Community input is essential in order to develop a plan that best meets Wayland's needs.
