Steve Garone Update on Eliot Pollak Memorial Bench:

Bob Smith, President of Dudley Pond Association- presenting for Steve Garone. Recap of when they came in about 6 months ago. Presented picture of where bench will go on a 4'x8' pad bench dimension 30 inches by 5 feet. Dudley Pond paid for bench and will pay for concrete pad on the beach. Will cost around \$1000-\$1200. Dudley Pond Association will pay for this. Meliones motion to approve Eliot Pollak Memorial Bench to be placed at Mansion Beach. Second Krasin. Vote unanimous in favor.

Foster motion to accept minutes from June 3, 2013. Second Meliones. Vote unanimous in favor.

Update on Loker Recreation Area planning work. McShea August 1<sup>st</sup> wetlands delineation will take place, emailed request for services from Doug Harris for the ceremonial stone survey, working design proposals stuff with John Moynihan.

Beach update: McShea updated the commission on the status of the basketball court and the dock at the beach. Lack of forward progress on the items continues. Meliones to check about path mat for the beach.

In fall set up hard dates of when things need to happen. And hold the group accountable to the work getting completed. Krasin holding folks accountable, we are paying full salary they should be doing the work.
