Brud called the meeting to Order.

Spring Town Meeting Warrant Articles

- Discuss Recreation Articles & Commissioner presentations for each article
- ARTICLE 22
 - Anna will Aidia Library to
 - Jessica -- Article #17, Anna does #17 and 22
 - Brud: 7 minutes for presentation Library, Aidia will have 7 minutes, Brud asks Anna to be present to cover 2-3 minutes
 - Anna going through warrant spending the money, FinCom? not very nice to us, expressed disappointment
 - Jessica: about CIP process
 - o WRAP supported Rec / in favor of spending article
 - Jessica: in favor of feasibility study, not nec town building renovations
 - o Brud article 22 50k for study, 100k for renovations not separate, linked together.
 - ASA confirms this is true
 - Brud controversy in people cut off turf construction, not controversial users want field upgraded
 - Asa get supporters of program out, good chance to get it passed
 - o Brud DPW voted unanimously in favor of spending article check with Stubby, didn't specify turf
 - Mike Lowry asked FinCom position? Move the money to a place where we can spend it, Mike indicated
 FinCom put their concerns before that of the towns
 - Brud needs Anna to lay out facts, Anna requests help from Jessica asks Anna to review summary.
 - Jessica reviews summary with Anna phrase/presentation
 - o Asa (presenting #6) similar, Heidi #5
 - Article 22 make clear the amount of money on each project highlight that WRAP and DPW support
 - Jessica: Town building soccer field irrigation discussion in touch with well driller, beginning permit process and estimate
 - o Brud need to water field; explains that Stubby and Chris Brown (chair) asked to take lead role in the project; when it comes time (money) that we're ready for the process. No potable water use, bylaws.
 - Brud asks How quickly can we resolve the water issue to continue- Jessica reports 20k-30k for a well
 - o Asa asks can we do the field for 100k, with 20-30k tied up in water system
 - Jessica Shrewsbury Landscapes confirms estimate includes irrigation costs of 20-30k
 - Anna ask solar panels location Jessica parking lot, drive under. There will be parking impact, possible shuttles.
 - Brud affirms that Anna will have a few minutes for article to highlight DPW and WRAP support
 - Other article put it out to bid, verified that it's all good.
 - o Brud do we need TA to sign the contract? Do we go through procurement?
 - Jessica any between 5k 25k we need 3 estimates, anything over 25k requires public bid. DPW can do some work in-house. Contracts through procurement and TA

- Anna requests he read it slower when presenting, and point out the articles that he references, and send to Jessica for review. Anna gives presentation advice.

- Frank asks Brud to read Article 7 gym usage Frank comments take the last bullet point (second section) and move it to the first bullet point
- o "not tax dollars" bold and capitalize highlight that point
- o Brud agrees; As a points out 'it's the law' and requests it be clearly pointed out that they are in violation of the law.
- Brud overheard that they are bothered when one board tries to take jurisdiction over another board,
 don't be confrontational we are just trying to operate our revolving fund.
- Jessica also recommends highlighting the Spending Cap factor we don't anticipate it being an issue going forward, as the Spending cap has promising outcome.
- Ass asks for update on the status of that Frank affirms it won't happen before Town Meeting
- Jessica confident it will pass sometime in May
- o Frank confirms there is no opposition, just needs to get it down.
- Brud will add that point and Jessica will send it out to the recreation field users
- Brud asks that we add a summary or 'cheat sheet' to indicate specific votes to supplement the RECREATION Commission goals. Jessica will add.
- Anna 'good idea!'
- Brud asks that we independently round up supporters from baseball, soccer, lacrosse, football, and WCPA. Brud saw Anil from Lacrosse- field user group Paul, Reed (soccer support) Frank and Asa (baseball support) requests contact for Lax and Pop Warner.
- Brud anticipates that ARTICLE 5,6 and 7 will come up the first night of Town Meeting

- Jessica asks Franks thoughts from time with committee; Frank explains consultant that they are
 confident it's where it should be Centrally located, no transportation issues, parking is adequate,
 seems to be no opposition points to municipal -- Jessica agrees with the support, and could see TB
 too.

- Anna backs sending FACT SHEET out to Field Users, Jessica will send instructions, Brud wants to trim down the data;

- Brud's comment UNCLEAR, seems like a committee was formed, -- BOPW, Stubby, HR/Nan, Schools, Paul Stein, Was it staff? Jessica confirms that staff develop outline of projects to present to respective boards. Brud confirms that Jessica would reach out to commission for support. The only catalyst or method of discovery for projects; when referring to recreation asset – we don't need that committee to also support – who has authority?
- Jessica: take TB as an example SC, BOPW, RC develop list of projects. If there is no controlling
 interest/owner, there'd be no authority. Brud asks if there is Informational discussion? Is there a voting
 consensus? Jessica will open conversations regarding projects once it gets into a construction phase
 DPW or Facilities would be involved. Recreation interests; stadiums under Ben. Budget for FY18 for
 projects. Mike would develop budget to compensate for the change.
- Brud says it's a good starting point, and well-intended concerned about the ultimate authority.
- Anna adds the intentions of including playgrounds and other rec areas under recreation jurisdiction, as schools have other priorities. HHollow field got real bad.
- Jessica iterates that the MOU will morph and change as we develop- intended to help strategic planning.
- Frank 8v8 Alpine field owned by SC
- Jessica reminds them, the faster the move, the faster we can move forward compile comments and concerns – before next meeting

Jessica sent Nan – and Nan provided to Selectman's meeting – identified where capital projects stand.
 Brud requests a resend

Frank request discuss BENCHES first

Outstanding Capital Projects Progress & Expected Progress:

• Capital Maintenance Projects

- o Benches, etc.
- Frank asks plan for benches at Cochituate Field?
 Jessica explains that benches are 15ft long
 - Frank objects, insists they are 12ft. Synthetic wood max 8ft. Aluminum can't be done
- New plan -- will replace natural wood.
- Brud asks-- some need complete replacement how many? A handful, Middle School,
 Cochituate (Bradford) has in ground benches.
- Status of Cochituate Field Benches Mike and DPW will replace the boards that need to be replaced due to safety concerns.
- Brud supports. Suggests we investigate where and how many benches we may want. Seniors,
 and lights, needs showy benches for public and pedestrians. Claypit has younger user base.
- 8ft pedestrian benches replace the boards with recycled plastic wood. Warranty issue.
- Frank says warranty is nonsense. As suggests liability insurance covers concerns.
- o Brud closes issue with DPW replacing the boards that pose a safety issue.
- Anna points out that budgeted 20k on benches that it will be much lower now.
- Anna points out we want to upgrade like nearby towns
- Jessica points out that we want to be consistent, colors, styles around town.
- Brud agrees with consistency.
- o Anna points out ADA accessible picnic tables
