- 8:20 p.m. Application of SARAH JOHNSON and KELLER MACMATH for any necessary approvals, special permits, and/or variances as may be required to change, alter, extend, a preexisting nonconforming structure (construct one story addition - 7' x 21') within required rear yard setbacks under the Town of Wayland Zoning By-Laws Chapter 198 Sections 201, 203, 401.1.2, 702.1, 702.3, 703.1 and 801-Table of Dimensional Requirements (rear yard). The property is located at 6 LAKEVIEW ROAD which is in a SINGLE RESIDENCE DISTRICT and AQUIFER PROTECTION DISTRICT. (#11-29)
