A public hearing will be held on May 22, 2012 at the TOWN BUILDING, 41 COCHITUATE ROAD, WAYLAND on the following applications at the time indicated:

- 8:20 p.m. Application of SUSAN and LEWIS COHN for any necessary approvals, special permits and/or variances as may be required to install additional signage (4 wall signs and modify 2 existing freestanding signs) in excess of 40 SF and allow a restaurant (Yogurt Shop) with 5 seats (indoor/outdoor) under the Town of Wayland Zoning By-Laws Chapter 198 Sections 201, 203, 501, 802 – Table of Permitted Principal Uses by Districts (Use #11 – Restaurant), 1102.1.1, 1103.1. The property is located at 131-133 MAIN STREET which is in a BUSINESS DISTRICT B. (12-12)
- 8:40 p.m. Application of BENJAMIN and MARCHELLA LEE for any necessary approvals, modifications, special permits, and/or variances as may be required to modify condition #1 of Special Permit #11-27 dated October 6, 2011 (add dormer to front elevation and increase overall height of second story addition) under the Town of Wayland Zoning By-Laws Chapter 198 Sections 201 and 203. The property is located at 421 OLD CONNECTICUT PATH, which is in a SINGLE RESIDENCE DISTRICT and AQUIFER PROTECTION DISTRICT. (12-13)
