- 8:20 p.m. Application of JOSEF and DANA VOLMAN for any necessary approvals, special permits and/or variances as may be required to change, alter, extend a pre-existing, non-conforming structure by more than 20% (demolish stone terrace and construct a one-story den) under the Town of Wayland Zoning By-Laws Chapter 198 Sections 201, 302, 401.1.2, 401.1.3 and 1604.2. The property is located at 5 OLD SUDBURY ROAD which is in a SINGLE RESIDENCE DISTRICT and AQUIFER PROTECTION DISTRICT. (14-07)
