8:20 p.m. Application of PAMELA and MATTHEW CERNE for any necessary approvals, special permit, and/or variance as may be required to change, alter, extend a pre-existing, nonconforming structure by more than 20% (demolish existing porch and playroom, construct a family room, mudroom, garage bay with masterbedroom above, extend kitchen with bedroom above.) under the Town of Wayland Zoning By-Laws Chapter 198 Sections 201, 203, 401.1.2 and 401.1.3.2. The property is located at 15 BALD ROCK ROAD which is in a SINGLE RESIDENCE DISTRICT. (14-11).
