    - a) Application received March 19, 2012 from Judy Schmitt from the Wellfleet Gardeners requesting the use of the driveway between Town Hall and Abiyoyo for a plant sale on May 26, 2012 from 7:00 a.m. and 2:00 p.m. 50 members of the Gardner's will be involved, no food or beverages will be served and money from the plant sale will be used to maintain the Library Garden and planting at the pier and Town island.
    - b) Applications received from Zena Bibler and Katie Baer Schetlick to use the following Town properties for the Fleet Moves Dance Festival: (1) Town Hall parking lot and Uncle Tim's Bridge on Friday, July 6 from 3:30 p.m. to 6 p.m. for a site-specific performance. (2) White Crest parking lots and White Crest Beach on Sunday, July 8, 2012 from 4:00 a.m. to 6:00 a.m. for a dawn performance. There will be a cast of 10-20 performers. No food and beverages served. Small-scales lighting and sound equipment used. Not a ticketed event but maps will be sold. (3) Sunday, July 8, 2012 for a closing night community dance at the Town Pier from 5:00 to 7:00 p.m. for set up and a party from 7:00 to 9:30 p.m. featuring local bands and a DJ. A suggested donation of \$5. Light refreshments offered. Will be using speakers, DJ and lighting equipment.
    - c) Application received from Amy Ryan from the Ryan Environmental Group to use Newcomb Hollow Beach from Wednesday, April 25 to Sunday, April 29, 2012 for one hour per day; 5:00 to 6:00 p.m. to build a small temporary habitat to reenact an indigenous lifestyle for educational purposes. 14 people involved and no food or beverages at the site. Area will be left in pristine condition. Not open to the public and no fees will be charged.
    - d) Application received from Jody Craven and Christa von der Luft of Cape Cod Bay Challenge, Inc. to use White Crest Beach on Saturday, June 9, 2012 from 10:00 a.m. to 2:00 p.m. to host an annual stand-up paddleboarding and surfing event. Approximately 40-50 participants expected to participate in two events: (1) A one hour 800-yard paddleboard race and 400-yard beach run and

- (2) a one-hour surf contest. \$25 registration fee per event, \$40 for both (\$15 per event or \$30 for both events for additional family members); all proceeds to benefit Christopher Haven.
- e) Application received from Jody Craven and Christa von der Luft of Cape Cod Bay Challenge, Inc. to use Mayo Beach and Baker's Field on Saturday, August 25, 2012; (1) Mayo Beach: 2:00-4:00 p.m. for a 35-mile stand-up paddleboard crossing of Cape Cod Bay to end at Mayo Beach, and (2) Baker's Field Tent Area: 12:00-9:00 p.m. for a post-event celebration and fundraiser at Baker's Field. Intent to provide live music, catered food, beer and wine, raffle items. Parking needed at the May Beach and Baker's Field Parking Lots. Paddlers will pay \$100 registration fee and raise an additional \$650 each to benefit Christopher Haven. A fee would be charged at the celebration event (approximately \$30) to cover food and beverage costs.
