

# Town of Wellfleet - Board of Selectmen Wellfleet Council of Aging June 24, 2008 Regular Meeting - Minutes

Chair Jacqui Beebe called the meeting to order at 7:00 p.m. Selectmen present included Dale Donovan, Jerry Houk, Michael May and Ira Wood. Town Administrator Paul Sieloff also attended.

#### I. Open Session & Announcements

- ♦ Construction work at the Fire Station will require the closing of Lawrence Rd to traffic immediately through June 27 and from July 1-3 during the hours of construction.
- The first movie at Preservation Hall will be shown July 1.
- Fourth of July the car parade starts around 9:30 and the main parade at 10 a.m.
- The Independence (from Fossil Fuel) Day announcement was noted.

Planning Board members asked for a response to their letter inquiring about the status of access to the Landing Strip parcel in the Marconi area of the National Seashore. Town Administrator Paul Sieloff said he had discussed the matter with the National Seashore. David Rowell of the Planning Board questioned the procedure. Gerald Parent discussed determining access to the property. Tom Reinhart asked about establishing the value of the parcel. Rowell said the case was to be brought to Land Court. Sieloff said he'd like this on the agenda for the next meeting after he consults with Town Counsel.

Dale Donovan discussed the appropriateness of the appointment of Bob Gross to the Marina Advisory Committee. He said it was proper, but in the future any possible perception of conflicts should be clarified in advance.

Since there were two applicants for reappointment to the Planning Board, Wood withdrew Motion 08-0204, and Houk withdrew his second so that the reappointments could be considered first.

◆ Planning Board Reappointments – Stephen Oliver and Ronald Harper Donovan explained rationale for changing the membership of the Board, keeping Ronald Harper on and not reappointing Stephen Oliver. Beebe discussed her view of the situation, deferring to the Planning Board chairman's wish to see Stephen Oliver retained. Stephen Oliver said he would like to stay on the Board. Jerry Houk expressed his reasons for not supporting Oliver. Gerald Parent, Vice-Chair of the Planning Board, spoke about the time and thought involved in working on bylaw change. Beebe said it would send a negative message to volunteer boards to not reappoint a present member of Planning Board. From the floor, Ben Zehnder discussed the dynamics of new members on the Zoning Board. Wood responded to some of Zehnder's remarks on political appointments. Donovan spoke about the importance of Planning Board's current work

There was discussion of getting the Conservation Agent's sign off for the requests. The Beach Administrator Suzanne Grout Thomas also discussed the number of applicants sharing the use of the Town beaches.

Planning Board's Review of Zoning By-law Amendments

Vice-Chair Gerald Parent said the draft Site Plan Review bylaw had gone to Town Counsel for review. Parent said Planning Board would be meeting with Non-Resident Taxpayers and the public during the summer. Beebe offered the services of Town Counsel at a future Planning Board meeting if they wish. David Rowell of Planning Board also discussed lot coverage issues.

Paul Sieloff had an item of new business he'd failed to mention during the New Business session of the meeting. He said the IRS had changed the mileage rates from 50.5 to 58 cents. He asked that the Selectmen approve the change. Houk said he'd like to think about it until the next meeting. Sieloff said that waiting until the next meeting would require some retro calculations. Donovan said that the Selectmen should also consider restricting travel. Wood asked for a list of those who use and receive mileage. From the floor, John Makely asked about those who get mileage. Sieloff said he would have the information for the next meeting.

Houk said that there should be an active Personnel Board in accordance with Charter specifications. He'd like this to be a future agenda item. Donovan said the Personnel Board needs to be revived with members to serve on it. Sieloff discussed getting good appointments to the Personnel Board because of liability concerns.
