◆ Judy Coburn, driver of the Flex Bus, asked why there was only one highway bus stop in the Town of Wellfleet. Police Chief Richard Rosenthal said he could raise the issue with the Flex Bus Administrator. Suzanne Thomas should also be notified, Beebe said.

• Gooz Draz said he had requested weekly updates on fund raising for the photo-voltaic solar panels at the Library. Beebe said that monthly reports were a more realistic expectation.

B. Landing Strip Access

Paul Sieloff, Denny O'Connell and the Selectmen discussed the Town Meeting vote to fund legal and other associated costs to establish access to the 46-acre property known as the Landing Strip Parcel (Map 42, Parcel 601) in the Marconi Area of the National Seashore.

Paul Sieloff directed Assistant Town Administrator Rex Peterson to send out the RFP for a survey of the Landing Strip property.

C. Personnel Board

Paul Sieloff said that the Town will move forward to get more appointments to the Personnel Board even though Town Counsel has advised caution. Wood said that the Charter language for the Personnel Board should be examined.

D. Parking Enforcement

Paul Sieloff said he had been working with Police Chief Rosenthal on parking. Sieloff said that current policy would stay in place. There was discussion of the earlier timed parking policy, signs, and enforcement of timed parking. Beebe said the policy should be clarified. Sieloff promised to report back at the next meeting.

E. Energy Audits

Sieloff said the Energy Audit was not yet completed, but he hoped to have it by the next meeting. F. Approval of IRS Standard Mileage Rate

Selectmen reviewed the use chart for mileage reimbursements to Town employees. There was a discussion of travel allowances for personal vehicles, putting into use more Town vehicles for travel and cutting back on expenses.

After Wood distributed some home grown vegetables, Jerry Houk discussed Brewster's Community Garden. Houk said he had investigated possible locations for a Wellfleet Community Garden and concluded that land near the COA was a good possibility. Sieloff reported on what the COA Director had said about that location. Wood said there had once been a community garden in the High Toss Road area. Celeste Makely's help was enlisted for a Community Garden project, and she graciously volunteered to be involved in the project.

MOTION 08-0224: To move that the Board of Selectmen approve the establishment of a Community Garden on Town-owned property at a location yet to be decided.

B. Planning Board's Review of Zoning By-law Amendments

Planning Board Chairman Denny O'Connell said that Planning Board had not met since the last Selectmen's meeting and had nothing new to report. Town Counsel Betsy Lane would be present at the next Planning Board meeting, he said. Wood offered to have Attorney John Whitten work on non-conformity issues with the Planning Board. Donovan suggested that the bylaw changes for Special Town Meeting apply to the Seashore District only in order to address an immediate problem – the threat to character of the National Seashore. Planning Board could continue to work on Site Plan Review and larger bylaw revision without a fall deadline, he said.

<u>MOTION 08-0227</u>: To move that the Board of Selectmen ask Town Counsel to specifically address the issues raised by Elizabeth Lane in her letter of March 14, 2008, and, following receipt of this, have a meeting with the Planning Board to review the issues.
