

Town of Wellfleet - Board of Selectmen

Wellfleet Public Library October 28, 2008 Regular Meeting - Minutes

The meeting was called to order at 7:00 p.m. by Chairwoman Jacqui Beebe. Selectmen present included Jerry Houk, Michael May, Ira Wood and Dale Donovan. Town Administrator Paul Sieloff also attended.

I. Public Hearing

A. Shellfish Grant Licenses

- 1. Margaret Shields to renew shellfish grant licenses #783 and 783A for a ten year period.
- 2. Rachel & David H. Ernst to transfer shellfish grant licenses #891 and 891A from David H., Rachel and David Ernst to David Ernst.

B. Banishment of Dogs

Discussion why two unrestrained dogs owned by Jane and Sam Scherer, 25 Pine Point Rd, Wellfleet, MA, should not be banished from the Town of Wellfleet.

Represented by Animal Control Officer Lorial Russell and Jane and Sam Scherer. Jacqui Beebe swore in the ... Lorial testified that 8 separate incidents occurred since the public hearing where the dogs were ordered to be confined to the property. Sam Scherer spoke about the fencing that was installed to confine the dogs on the property. Ms. Lorial informed the board that she has not yet inspected the fence. Mr. Scherer stated that a Police Officer went over to the property to inspect the fencing. Ms. Beebe questioned why it has taken this long for the owners to fix the issues of the dogs escaping through the fencing. Ms. Jane Scherer spoke about their efforts to confine the dogs. John Makely spoke in favor of an electric fencing device. Chief Rosenthal confirmed that officers did go over to the property to validate the fencing. Ms. Beebe read a letter by abutters Marianne McCaffery, Deirde Marsh, Judy Hogan and Eastham resident Mary Beth Travis. Dale Donovan recited the Bylaws pertaining to dogs and the Charter of the Selectmen's responsibility to enforce the laws of the Town. Lorial Russell stated that the male dog is aggressive, and the female is not.

C. Amend Shellfish Rules and Regulations

To hear a petition to add the following to the Shellfish Rules and Regulations:

Section 2.1 Definitions

Petite Oysters – Oysters whose length is between 2.5 and 3 inches.

Section 8 General and Commercial Regulations

8.1.5 A Grant license holder may harvest and sell petite oysters (between 2.5 and 3 inches in length) only if:

- a) They do not have a Town of Wellfleet commercial shellfish permit;
- b) They have documented proof of purchase of seed;
- c) They have the required amendment to their propagation permit, granted by the State, allowing them to sell petite oysters to a previously designated dealer, approved by the State;
- d) They, or their employees (as defined in 11.1.2 and 11.1.3) or their families do not store any oysters harvested in from the wild on their licensed area(s);
- e) They are limited to selling petite oysters for a term of not less than a year, beginning with the routine issuance of an annual propagation permit from the State;
- f) They forfeit any claim to a hardship waiver under Section 4.1.4 of Wellfleet Shellfish Regulations.

Sections 8.1.6 through 8.1.20 to then be re-numbered.

Represented by Shellfish Andy Koch. He notified the Board the reasoning behind the proposed amendments. Mr. Donovan would like to continue this to the next meeting.

<u>MOTION 08-0306</u>: To move that the Board of Selectmen vote to approve the Amended Shellfish Rules and Regulations with the addition of "Town of Wellfleet" in 8.1.5.a and change the word "in" to "from" in 8.1.5.d.

She went to the Marina Advisory Board and they felt that there was too much going on at the Marina and suggested the shack possibly being located at the old anchor memorial. She is requesting that the Selectmen approve the new location. Mr. Houk does not like the suggested location. The board discussed locations.
