Fire Chief Dan Silverman read a letter he submitted to the Board of Selectmen. The Fire Association will donate \$2,000 towards the purchase of the stove. Additionally, Dan Silverman will reimburse \$1,000 personally. An anonymous citizen donated \$500 as well. He gave three checks to the Town Administrator. Jerry Houk felt that Chief's personal donation was not proper but thinks it's very admirable. Both Jacqui and Dale agree with Jerry but would not like accepting his donation. Hugh Guilderson asked what assurance the Town will properly procure goods and services. Jacqui mentioned that it was not the procedures followed that was the issue, but the specification which were bid out.
