WHEREAS, housing costs in Wellfleet continue to escalate due to the pressure created by the tourist/second home market, which threatens the ability of residents to remain in Wellfleet and the ability of businesses to access the labor force they need; and

WHEREAS, the Town of Wellfleet considers it a top public policy priority to preserve affordable rental housing; and

WHEREAS, the Town desires to increase the number of rental housing units in Wellfleet that are affordable;

THEREFORE, the Town's representative in the General Court is instructed to file a home rule petition for a special act entitled, "An Act Relative to Property Tax Exemptions for Rental Properties in the Town of Wellfleet Restricted as Affordable Housing" to read as follows:

SECTION 1. Notwithstanding the provisions of any general or special law to the contrary, dwelling units occupied by income eligible occupants and rented in accordance with Fair Market Rental Guidelines shall be exempt from taxation under chapter 59 of the General Laws.

SECTION 2. All occupants of the affordable dwelling unit shall upon initial application and annually thereafter on the first of September, submit to the Town or its agent necessary documentation to confirm their eligibility for the dwelling unit. Specifically, all dwelling units

must be rented to those meeting the guidelines for a low or moderate income family. For the purpose of this section, low income families shall have an income less than eighty (80) percent of the Town of Wellfleet median family income, and moderate income families shall have an income between eighty (80) and one hundred twenty (120) percent of the Town of Wellfleet median family income, as determined by the United States Department of Housing and Urban Development (HUD) Published Income Guidelines, and as may from time to time be amended.

SECTION 3. Maximum rents shall be established in accordance with HUD published Fair Market Rental Guidelines. Property owners are required to submit to the Town or its agent information on the rents to be charged. Each year thereafter on the first of September, they shall submit information on annual rents charged and a signed lease to the Town or its agent. Forms for this purpose shall be provided. Rents may be adjusted annually in accordance with amendments to the Fair Market Rental Guidelines.

SECTION 4. Such exemption shall be equal to the tax otherwise owed on the property based on the assessed value of the entire property, including any accessory dwelling units, multiplied by the square feet of the living space of all accessory dwelling units on the property that are restricted to occupancy by low or moderate income households, divided by the total square feet of all structures on the property. For any property with a single dwelling unit, the exemption allowed shall not exceed 50% of the tax otherwise owed. For purposes of determining the assessed value of the entire property, if by income approach to value, such assessment shall assume that all housing units are rented at fair market value.

SECTION 5. The date of determination as to the qualifying factors required by this act shall be September first of each year.

SECTION 6. This act shall be submitted to the voters of said town at the next annual or special town election in the form of the following question which shall be placed upon the official ballot to be used at said election: Shall an act passed by the General Court in the year 2004 entitled "An Act Relative to Property Tax Exemptions for Rental Properties in the Town of Wellfleet Restricted as Affordable Housing", be accepted? If a majority of the voters cast in answer to said question is in the affirmative, then Sections 1, 2, 3, 4 and 5 of this act shall thereupon take effect, but not otherwise.

SECTION 7. Section 6 of this act shall take effect upon its passage. The General Court may only make clerical or editorial changes of form to the bill, unless the Board of Selectmen approved amendments to the bill before enactment by the General Court. The Board of Selectmen is hereby authorized to approve amendments that are within the scope of the general public objectives of this petition.

This article will instruct the Town's representative in the General Court to file a home rule petition for a special act entitled "An Act Relative to Property Tax Exemptions for Rental Properties in the Town of Wellfleet Restricted as Affordable Housing". The act would allow a property tax exemption on the portion of a property that is deed restricted and rented affordably, in accordance with Department of Housing and Urban Development (HUD) guidelines. Property owners must file documentation annually in order to qualify for the exemption.

This article was originally approved at Annual Town Meeting in 2004. The Home Rule Petition was filed, but was not passed. In order to re-file the special legislation, a vote to "refresh" the Town's approval is required.

Our Planning Committee has identified six priority objectives in furtherance thereof; which we recommend is addressed immediately, i.e., within the next twelve months:

- 1. Improve our community health facilities, including the reestablishment of a local pharmacy.
- 2. Protect and preserve open space for future generations, and acquire properties linking present open space parcels, especially those with shoreline access
- 3. Protect and preserve water resources, both in terms of potability and treatment of wastewater.
- 4. Develop plans for community housing which will permit diverse populations to continue to live in our town.
- 5. Establish a blue ribbon commission to identify and recruit year-round business enterprises and activities, including off-season uses of our Harbor and Marina areas, which will be friendly to our environment.
- 6. Protect and preserve our beaches and shorefront areas for recreation and industry.

Many Town committees focus on these areas. They need to talk to each other. We therefore highly recommend that quarterly meetings of groups identified, on both the staff and committee level become common practice.

Our Update comprises 13 major areas, including some topics not in previous Plans. Highlights of specific planning goals for each area, which we recommend be addressed within the next one to three years, include:

Land Use: Develop detailed land use plan for remaining undeveloped land in Town. Identify historic districts and flood zones.

Natural Resources: Establish Citizens Wastewater Advisory Committee. Complete Herring River Restoration project.

<u>Open Space</u>: Complete comprehensive management plan for all Town-owned land. Protect traditional viewsheds and scenic roads.

Economic Development: Lobby for and impose local option excise taxes on rooms and meals to be used in part to support year-round economic development activities

<u>Community Housing</u>: Continue initiatives which provide short-term relief to Wellfleet-related residents. Develop Community Housing Action Plan.

<u>Historic Preservation:</u> Establish Local Historic District Study Committees to begin designation of Central Village and Pond Hill School Historic Districts

Human & Health Services: Establish a paid part-time Human Services Coordinator

Energy & Conservation: Create a Standing Town Energy Committee with staff support to devise a Wellfleet Energy Plan

Community Facilities: Complete construction, design & funding plans as needed for new fire and police stations

Education: Continue to address financial issues, both through seeking a more balanced state school aid formula and creating worst-case contingency scenarios.

Recreation: Adopt a long-range vision including additional activities for retirees

Marina & Harbor: Support Phase II of Marina Restoration

Transportation: Make downtown Wellfleet more pedestrian and bicycle friendly
