**ARTICLE 1.** To see if the Town will vote to transfer from available funds and/or authorize the transfer from various line items within current appropriations, such sums of money necessary to supplement the operating and/or capital budgets of the various Town departments for the current fiscal year 2005-2006:

**ARTICLE 2.** To see if the Town will vote to transfer the care, custody, management and control of a portion of the land described below owned by the Town, located at 335 Main Street and being a portion of the premises described in deed to the Town recorded with Barnstable County Registry of Deeds in Book 14142, Page 238 and identified on Tax Assessor's Map 14 as Parcel 173 all as shown on a Sketch Plan entitled "Sketch of Land in Wellfleet made for the Cape Cod Five Cents Savings Bank" filed with the Town Clerk and currently held by the Board of Selectmen for general municipal purposes to the Board of Selectmen for the purpose of granting a permanent easement for the benefit of the Cape Cod Five Cents Savings Bank and its property located at 345 Main Street, and to authorize the Board of Selectmen to grant said easement upon such terms and conditions as it shall determine appropriate.

**ARTICLE 3.** To see if the Town will vote to authorize the Board of Selectmen to acquire by purchase, gift, eminent domain, or otherwise and to accept the deed to the Town of fee simple interest in the parcel of land and the buildings thereon located at 2896 State Highway, Wellfleet containing 60,560 square feet of land, more or less being the same land described in Deed recorded with Barnstable County Registry of Deeds in Book 15888, Page 168, Assessors' Map No.13, Parcel No.3, known as the Gutsy Bender's Restaurant, said property to be held under the care, custody, control, and management of the Board of Selectmen, and to enter into all agreements and execute any and all instruments as may be necessary on behalf of the Town to effect said purchase and further to appropriate \$625,000 for said acquisition, to determine whether said sum shall be raised by borrowing or otherwise, by whom expended.

2/3 vote attained that the Town hereby authorizes the Board of Selectmen to acquire by purchase, gift, eminent domain, or otherwise and to accept the deed to the Town of fee simple interest in the parcel of land and the buildings thereon located at 2896 Highway, Wellfleet containing 60,560 square feet of land, more or less being the same land described in Deed recorded with Barnstable County Registry of Deeds in Book 15,888, Page 168, Assessors' Map No.13, Parcel 3, known as the Gutsy Bender's Restaurant, said property to be held under the care, custody, control, and management of the Board of Selectmen, and to enter into all agreements and execute any and all instruments as may be necessary on behalf of the Town to effect said purchase and, further, that the sum of \$625,000 be and herby is appropriated to pay the costs of the acquisition of the foregoing property, and for the payment of all other costs incidental and related thereto, and to meet this appropriation, the Town Treasurer, with the approval of the Board of Selectmen, is hereby authorized to borrow said amount under and pursuant to chapter 44 S. 7(3) of the General Laws, or pursuant to any other enabling authority, and to issue bonds or notes of the Town therefor.

**ARTICLE 4.** To see if the Town will vote to raise and appropriate, transfer from available funds or borrow the sum of \$200,000, or any other sum, for the purpose of demolishing the rectory portion of the 335 Main Street property.
