ARTICLE 3: To see if the Town will vote to transfer the sum of \$25,000 from Free Cash to Shellfish Capital Budget 179, for the purchase and to equip a new truck for the Shellfish Department..

FINANCE COMMITTEE DOES NOT RECOMMEND 7-0

The Selectmen have voted to endorse the Finance Committee's recommendations for a vehicle rollover policy to justify decisions of replacing Town-owned vehicles. As the warrant goes to press, The Finance Committee has not been provided with the vehicle maintenance records and other data to indicate that a new shellfish truck is necessary at this time.

Minority opinion: This vehicle should not be bought with free cash. Replacement of this vehicle is not an emergency and it should be requested in the Shellfish Department's Capital Budget at the Annual Town Meeting.

ARTICLE 4: To see if the Town will vote to transfer the sum of \$34,000 from Free Cash to Police Operating Budget 210, for the purchase and equip a new cruiser for the Police Department.

FINANCE COMMITTEE RECOMMENDS 7-1

The Selectmen have voted to endorse the Finance Committee's recommendation for a vehicle rollover policy to justify decisions of replacing Town-owned vehicles. The Finance Committee has been provided with the Police Department's vehicle maintenance records and other data to indicate that a new cruiser is necessary at this time.

FINANCE COMMITTEE RECOMMENDS 7-0

The Finance Committee believes that increasing the stock of affordable housing in Wellfleet is an important way to attract and retain: Town employees, trades people, public school educators, and young families. Affordable housing is one of the allowable uses of these funds under the enabling legislation.

ARTICLE 10: To see if the Town will vote, pursuant to MGL c.44B, to appropriate from the Community Preservation Fund estimated annual revenues, fund balance or historic preservation reserve the sum of \$270,000 to contribute to the cost of, and thereby support, the purchase of a portion of the property at 258 Main Street, Assessor's Map 15, Lot 46, for the development of additional storage and exhibition space for the Wellfleet Historical Society Museum.

ARTICLE 11: To see if the Town will vote, pursuant to MGL c.44B, to appropriate from the Community Preservation Fund estimated annual revenues, fund balance or historic preservation reserve the sum of \$500,000 to contribute to the cost of, and thereby support, the restoration and renovation of a portion of the property at 335 Main Street, Assessor's Map 14, Lot 173, for the development of a community and cultural center to be known as Wellfleet Preservation Hall.

FINANCE COMMITTEE RECOMMENDS 2-1-3

The Finance Committee believes this to be a worthy project but we need to be sure the Purchase and Sale Agreement has been signed before we recommend the warrant article.

Voice vote that the Town appropriate the sum of \$500,000 to fund a grant to the Wellfleet Preservation Hall for the purpose of the restoration and renovation of a portion of the property located at 335 Main Street, Assessor's Map 14, Lot 173 for the development of community and cultural center, pursuant to a grant agreement, and further, to authorize the Board of Selectmen to enter into said grant agreement which agreement shall set forth the terms and conditions under which such funds

may be expended, and to meet this appropriation, \$167,422 be transferred from the Community Preservation Reserve fund balance and the sum of \$332,578 be transferred from Community Preservation Fund estimated revenues

ARTICLE 12: To see if the Town will vote, pursuant to MGL c.44B, to appropriate from the Community Preservation Fund estimated annual revenues or fund balance the sum of \$18,000 to contribute to the cost of, and thereby support, the restoration and renovation of the Skateboard Park at Mayo Beach.

FINANCE COMMITTEE DOES NOT RECOMMEND 7-0

The Finance Committee believes that significant public funds have been recently expended for this project, and that the funds need to be raised without using public funds.

ARTICLE 13: To see if the Town will vote pursuant to Article II, Section 7 of the Town of Wellfleet Bylaws to authorize the Board of Selectmen to transfer jurisdiction and control of land on Chequessett Neck Road and Atwood Avenue known as lots 106 on Assessor's Map 14 and Lot 295 on Assessor's Map 12 to the Habitat for Humanity of Cape Cod for the purpose of providing affordable housing for low and moderate income residents of all ages provided said property shall be made available to Wellfleet residents under a local preference program to the extent permissible by law; said land shall not exceed 0.71 acres. The deed transferring the land to the Housing Authority shall provide that in the event the land ceases to be used for the purposes provided herein or if the housing construction has not begun on the land within 10 years from the date the title to said land is transferred to the Housing Authority, the title to said land will revert back to the Town of Wellfleet and become vested in the inhabitants of the Town of Wellfleet

FINANCE COMMITTEE RECOMMENDS 6-1 BOARD OF SELECTMEN RECOMMENDS 5-0 LOCAL HOUSING PARTNERSHIP HAS NO RECOMMENDATION HOUSING AUTHORITY RECOMMENDS 4-0

Because of a lack of recommendation a 2/3 voice vote was attained to hear article.

Voice vote to change the purpose for which the below-described land is held to being held for conveyance, and to authorize the Board of Selectmen to execute a deed to Habitat for Humanity of Cape cod transferring the land on Chequessett Neck Road and Atwood Avenue known as Lot 106 on Assessor's Map 14 and Lot 295 on Assessor's Map 12 for the purpose of providing affordable housing for low and moderate income residents of all ages provided said property shall be made available to Wellfleet residents under a local preference program to the extent permitted by law; and said deed shall provide that in the event the land ceases to be used for the purposes provided herein or if the construction of housing has not begun within 10 years from the date of the deed, the title to the land shall revert to the Town.

ARTICLE 14. To see if the Town will vote pursuant to Article II, Section 7 of the Town of Wellfleet Bylaws to authorize the Board of Selectmen to transfer jurisdiction and control of land on Old King's Highway known as lots 110, 111 and 143 on Assessor's Map 16 to the Housing Authority for the purpose of providing affordable housing for low and moderate income residents of all ages provided said property shall be made available to Wellfleet residents under a local preference program to the extent permissible by law; said land shall not exceed 2.88 acres. The deed transferring the land to the Housing Authority shall provide that in the event the land ceases to be used for the purposes provided herein or if the housing construction has not begun on the land within 10 years from the date the title to said land is transferred to the Housing Authority, the title to said land will revert back to the Town of Wellfleet and become vested in the inhabitants of the Town of Wellfleet.

FINANCE COMMITTEE RECOMMENDS 7-0-1

The Finance Committee believes this to be a worthy project. However, before recommending this article, we wanted more information about whether the Town may want to use this property as the site for a water tower.

ARTICLE 15. To see if the Town will vote to appropriate a sum of money to pay costs of designing, constructing, originally equipping and furnishing a new fire station, and for the payment of all other costs incidental and related thereto, and that to meet this appropriation, the Town Treasurer, with the approval of the Selectmen be and hereby is authorized to borrow said amount under and pursuant to Chapter 44, Section 7(3) of the General Laws, or pursuant to any other enabling authority, and to issue bonds or notes of the Town therefore; provided, however that no sums shall be borrowed or expended hereunder unless and until the Town shall have voted to exclude the amounts necessary to pay debt service on any bonds or noted issued pursuant to this vote from the limits of Chapter 59, Section 21C of the General Laws (Proposition 2 ½).

FINANCE COMMITTEE RECOMMENDS 7-0

The timing of the bid process prevented the Finance Committee from having the final cost of the new fire station by the time the warrant was printed. We require the final cost in order to recommend the warrant article. However, the Finance Committee wants Town Meeting to know that we are all in favor of the project.

BUILDING NEEDS & ASSESSMENT RECOMMENDS 4-0

2/3 Voice vote that the sum of \$6,595,598 be and hereby is appropriated to pay costs of designing, constructing, originally equipping and furnishing a new fire station, and for the payment of all other costs incidental and related thereto, and that to meet this appropriation, the Town Treasurer, with the approval of the Selectmen be and hereby is authorized to borrow said amount under and pursuant to Chapter 44, Section 7(3) of the General Laws, or pursuant to any other enabling authority, and to issue bonds or notes of the Town therefor; provided, however, that no sums shall be borrowed or expended hereunder unless and until the Town shall have voted to exclude the amounts necessary to pay debt service on any bonds or notes issued pursuant to this vote from the limits of Chapter 59, Section 21 C of the General Laws (Proposition $2\frac{1}{2}$).

In accordance with the Warrant the polls were opened at 12:00 Noon by the Warden. The ballot box read 0000. Lunch provided by Dawn Rickman from Box Lunch. Very good as usual. At 12:20pm the Handicap voting machine was tested and sample ballot put through the ballot box. At 2:00 pm the ballot box was emptied reading 202. At 3:30 pm the ballot box was emptied reading 346. At 4:40 pm the ballot box emptied reading 475. At 5:45 pm the ballot box emptied reading 553. The polls closed at 7:00 pm with the ballot box reading 610 (609 because of the test ballot).
