At 8:30 a.m. the Design Review Board met with Allison Lindsay Giamarco, co-owner of Lindsay Taylor Spatique and Megan Bradley, Sunshine Signs located at 71 East Main Street to review their new signage.

Member Charlie Diamond said at the last meeting we decided that the letter was too high and he understands that today they have an alternative proposal.

Ms. Lindsay Taylor Giamarco said this will be a free standing ground sign with an oval shape and a matte finish for the background and the lettering is 3/16" PVC letter forms with matte painted finish. The vinyl will be digital print on matte finish; the paint is MP Brushed Aluminum – Matte Finish; the paint to match PMS #7459C – Matte finish; and paint to match PMS Warm Gray 11C – Matte finish.

Member Charlie Diamond asked about specifications on the lighting to be used.

Allison Lindsay Giamarco said they do not have information with them on the lighting specifications and will deliver to the Design Review Board as soon as they are ready.

The Town Planner said when you are ready to install your lighting, first take it to the Building Commissioner who will then review it with him. He will then contact you with a date to come back before the Design Review Board. When someone comes in bring in a specification sheet and a sample of the light to be used.

Member Charlie Diamond motioned to approve Lindsay-Taylor Spatique Sign with Specification Sheet dated July 28, 2016, # 70335 R2, Sign Type A, drawn by Sunshine Sign. No lighting is approved with this vote. The Applicant shall return to the Design Review Board prior to installation of lighting for their sign. At that time, the Applicant shall provide the Board with lighting plans and specifications. The motion was seconded by Member Todd Alexander and unanimously voted.

There being no further business to discuss, the meeting adjourned at 9:00 a.m.
