Minutes of Board of Health Meeting November 15, 2011

The regular Board of Health meeting was held on Tuesday, November 15, 2011, in room 24 in the Forbes Municipal Building. The meeting was called to order at 5:30 pm. by Chairman Federici. Those present were Members Ehrlich and Walsh, Director McNulty, Sanitarian Baccari and Inspector Gilchrist. Bills and payroll were signed.

Director's report (October) was discussed and approved. A recent administrative meeting held with the owners and manager of Acacia Functions (Indian Meadows) was discussed. The owners are very rarely there; the manager, Kenny, runs the day-to-day operations. He was also the manager of the original Indian Meadows restaurant. Cleaning is very often postponed for several days after a function has been held. Cleaning is done by a couple hired by the owners. A new pest control company has been hired. The Health Inspector recommended the owners hire a food service consultant. Member Ehrlich said he wants the owners to attend the Board's January meeting. Chairman Federici said she would like a plan submitted in December and the Board will discuss it with them in January.

Member Ehrlich made a motion for the owners of Acacia Functions to submit a detailed, written plan by the week of December 5th outlining cleaning procedures at their facility and how the procedures will be implemented. Member Walsh seconded the motion; the vote was unanimous.

Sanitarian's report (October) was discussed and approved.

Health Inspector's report (October) was discussed and approved.

OLD BUSINESS

Robert Bladd - 5:45 P.M. - Continuation of Public Hearing

The Board met with Mr. Bladd, 135 East Main Street, Apt. #H-10. This is a continuation of a hearing from last month's (October) meeting.

Director McNulty provided background information.

At last month's meeting, Mr. Bladd had asked the Board to rescind Sanitarian Baccari's order dated September 22, 2011, to clean food debris from around his stove and refrigerator. The Board continued the hearing until this meeting based upon the assumption that the cleaning would done during the interim. Sanitarian Baccari conducted an inspection on October 25th and everything was cleaned.

Member Walsh made a motion to rescind the order. Chairman Federici seconded the motion; the vote was unanimous.
