Vice Chairman Jane´ informed the Board that a hearing regarding the conservation bylaws will be held on Monday, December 21st at 7:00 p.m. and encouraged a Board of Selectmen member to attend the hearing to understand the new bylaws and voice any concerns. After a brief discussion regarding the conservation bylaws hearing Vice Chairman Jane´ moved that the Board authorize himself on behalf of the EDC and a member of the Board of Selectmen to attend the Conservation Commission meeting to request that the hearing process for the approval of the regulations be extended for 60 days and further voted that during that time frame that an economic impact analysis be conducted by the EDC and for the EDC revisit the Conservation Commission with their findings. Selectman Goldblatt seconded. 3-2 (Chairman Emery and Selectmen Dodd)

Chairman Emery voiced get well wishes to Shirley Brady. Chairman Emery noted that at the special town meeting a resident complained to the Town Moderator regarding the order of the warrant articles for town meeting. Mr. Harrington addressed the resident's concern in writing and also called her to explain the local government process. A lengthy conservation pursued regarding the order of the articles along with favoring specific groups..etc. After the conversation the Board agreed to place this item at their January 2010 meeting.
