Article #6 Fiscal Year 2014 Operating Budget

Motion I move that the Town vote to raise and appropriate such sums of money as

may be necessary to defray the expenses of the several town departments for the ensuing fiscal year and that each total read by the Moderator be considered a separate motion made for each of the line items making up that total in the column marked FY2014 recommended. I further move that the total amount raised be reduced by the transfer from Country Club – Retained Earnings of \$40,000 and that the balance be raised and

appropriated.

Article #7 Regularly Recurring Articles

Motion I move that the Town vote to approve Article 7, Sections A - C and that the

Town vote to raise and appropriate the sum of \$300,000, transfer and appropriate \$50,000 from Water Retained Earnings, transfer and appropriate \$50,000 from Sewer Retained Earnings and transfer and appropriate \$20,000 from Country Club Retained Earnings for the purpose of Article 7D; raise and appropriate \$2,500 for the purpose of Article 7E; approve Article 7F as printed in the warrant; transfer from available funds the sum of \$824,286 for the purpose of Article 7G; and raise and

appropriate the sum of \$6,600 for FY14 for the purpose of Article 7H.

Article #8 Capital Improvement Plan
