Nuisance Complaint, 68 Bowen Street, Roosters

A series of emails is in the agenda regarding a nuisance complaint of roosters crowing all day at 68 Bowen Street, property owner Diana Engelbart. Resident Patrick Crowley, 64 Bowen Street is in attendance and commented that he is not the resident who complained about the roosters at 68 Bowen Street this time. Mr. Crowley reminded the Board of the same problem he had in August of 2011. He further commented he would be pleased for the problem to be abated. Mr. Crowley explained that the cages already exist for the roosters. He was told by Ms. Engelbart that she will be taking the roosters and the cages to the new location at 77 Lee Street. After discussion and motion of Mrs. Henderson and second of Mrs. Hartigan, it was voted all in favor to send an Order to Ms. Engelbart to abate the nuisance by April 5, 2013. The Order will be deliverd by a constable.

The Board of Health will contact the Zoning Board of Appeals to discuss possibilities for zoning regarding farm animals in a residential neighborhood.

<u>Certificate of Compliance for 97 Lee Street</u> After review and upon motion of Mrs. Salate and second of Mrs. Henderson it was voted all in favor to approve the As-built drawing and Certificate of Compliance for 97 Lee Street prepared by Ross Associates in October 2012 numbered L11849.

<u>Drug Take Back Kiosk</u> The Police Department has received the Drug Take Back kiosk for the residents of West Boylston. There was a discussion about how to get the word to the residents that the kiosk is there and how it is to be used. The Board is in favor of some type of press announcement in the Banner and/or some other place. Chief Minnich will be contacted to get his opinion on how he would like this handled.

<u>Document Scanning Information</u> Mr. Mike Soltys of Innovative Document Imaging came to the Board office, looked over the files and was informed of the Boards goal. He took some information with him and prepared a disc and an on line sample of what his company has to offer as well as an estimate of the cost which was \$42,256.00. The Board will check with other communities to see if and how this was done for them.
