1 Boston Cane Presentation

Clarence Cormier, was presented the Boston Cane on Wed., June 27th at the Board of Selectmen's Meeting. The presentation ceremony and reception went well, and was enjoyed by all. Neil Norum took commemorative pictures that will be given to Mr. Cormier.

Nancy Lucier will be given a listing of all of the prior recipients of the Boston Post Cane so that their names may be engraved for the wall plaque.

2 Joseph Dwelley Headstone

Neil Norum, who also serves as the towns Veterans Agent, has the necessary paperwork all ready to mail out to the state. The paperwork will also require the Cemetery Superintendent and Town Clerk to sign off on delivery of the stone. The marble tombstone is due to be delivered in approximately two months, marble tombstone. June 6- 8th is the Revolutionary War reenactment, road race and muster, will be held, we would like to dedicate Dwelley's marble headstone with these events.

Planning on a dedication ceremony on July 20, 2008 with the presentation of the Lovell Bell, and listing in the National Register of Historic Places.

4 Demolition of property at 19 Crescent St

MHC submitted a letter to hold up the demolition of this project. The Historical Commission has signed off on the property to be demolished. The Fire Dept. had scheduled to conduct training sessions with controlled burns of the building. Karen Footner wrote a letter to the MHC stating that this property is listed in the Mass. Inventory, and was concerned about a Historic building being destroyed. Fire Chief Pauley is in direct contact with the MHC to pursue completion of the demolition and the time frame in

which this project may proceed. Beverly has notified that MHC that there is no historic architectural significance to the building. Only reason the property is listed is that it is in the Quebec inventory.
