Although there was no evidence that Sarah Adams received the cane, her obituary in 1996 stated that she was the holder of the Boston Post Cane. Upon motion of Dennis, second by Neil, it was voted to include her name on the plaque.

<u>Helen Kelly:</u> Following much discussion, it was voted to present a Boston Post Cane certificate to Helen Kelly at a luncheon at the Senior Center where she goes for lunch every Monday and Friday. Have a member of the Board of selectmen do the presentation and perhaps have the Council on Aging could provide a cake that they could serve for dessert after lunch. A tentative date of April 8 is scheduled for the occasion.

#### Edgar A. Whitcomb Award:

Bev nominated Phil Chevalier to be the recipient of this year's award for all the years he has been plowing the society property. Phil does the initial plowing and Aaron does the cleaning up and the shoveling of the walk ways. Upon motion of Neil, second by Dennis it was a unanimous vote.

#### Christmas tree on the common:

The topic of cutting down the tree on the common that is lighted every year came up for discussion. The tree is a commemorative one and has a plaque at its base stating:

# "1732-1932 George Washington Bicentennial Given by

Woman's Club of West Boylston"

Bev suggested contacting Michael Mulryan, a certified arborist, to make a professional assessment of the tree and to provide us with a copy of his findings.

Upon motion of Dennis, second by Neil, it was voted to approve Bev sending a letter to Leon stating the Commission's stand on the issue of the tree. The letter will express the Commission's remarks made at the meeting stating that we are not in favor of cutting down a piece of history – namely a commemorative tree simply because it's inconvenient to light it at Christmas time.
