### Parks Facilities/Maintenance Items

Anthony was unable to attend the meeting and did not send an email with updates. Jim expressed concerned that it is March and the seasonal part-time employee has not been hired. John will check with Anthony regarding the status of the advertising/hiring of the position.

Jim stated that the outfield fencing on the "A&B" fields needs to be addressed. Jim had looked into pricing for fencing and thinks the cost for both fields was \$2,500.

#### **Old/New Business**

The board reviewed the proposed changes to the usage request form. Chris Rucho has agreed to create the fill-in and print version, once the changes are approved (will be done in conjunction with the public hearing).

Jim has borrowed from Pat Inderwish a copy of the maintenance manual for the courts at Goodale Park. Bob has volunteered to go thru the documents, which contain extensive information, and extract the maintenance information. The maintenance of the courts is not included in the current Parks Maintenance Plan. The board discussed the need for the board to obtain a copy of the court maintenance manual.

The board reviewed and discussed the quotes that Steve obtained for the sound system at the All-Purpose Field. Whereas the system is not needed until the fall and the lack of funds available, the board will hold off on making the purchase.

Removal of the wax on the basketball courts can not be addressed because of amount of snow.

Gary will get information on building metal dugouts at the Sr. Baseball Field and report back at the next meeting. This would be a project that would be done in the fall, when the field is not in use.

It is too late to apply for CPA funds for fencing for the Sr. Baseball Field, to be voted on at the May Town Meeting. It will have to wait until the Town Meeting in the fall. Bob suggested looking at the entirety of the Goodale Park area, identifying what needs to be fixed, and requesting funds from the CPC for the Fall meeting.

Mulch requirements for Pride Park can not be evaluated until the snow has melted.

The board discussed warning tracks at the "A&B" fields and if volunteers could assist with the project. Anthony will need to be consulted on the matter.

The board reviewed and discussed the proposed changes to the fee schedule. Steve would like to start charging (reservation) fee for the gazebo/common again. It has not been charged since the scheduling was taken over by the Town Administrator (a few years back), which has since been given back to the Parks Commission. It was decided to keep the gazebo/common fee on the fee schedule, but to change the fee for the "up to 3 hours" to \$100. The board also discussed the changing "waive a fee" to "reduce a fee".

Jim would like to see batting cages as part of the master plan being developed. Chris suggested looking at organizations to run fundraisers, to help pay for batting cages.

The board discussed possible uses for the land at Mixter and if the land was designated for parks. John will speak with Leon regarding the matter.

The flag at the All-Purpose Field was not taken down and will have to remain up until the snow cover diminishes.

Steve noted that the tribute area needs to be included in the master plan, as previously discussed with the Naming Committee.

# Committee Updates/PFC, Open Space, Rules & Fees

The Open Space Committee is considering applying for CPA funds to update the Open Space Plan and would like the board's blessing to do so. It was questioned whether the funds could be used for that purpose.

The board discussed what the roles and responsibilities are of the Parks Commission, Open Space Committee and Parks Facility Committee. John will contact the Town Administrator to set-up a meeting with the board, the two committees and the Town Administrator (tentative date Mar 30).
