- To see if the Town will vote to raise and appropriate or transfer from available funds, subject to receipt of a Commonwealth of Massachusetts, Executive Office of Environmental Affairs, Division of Conservation Services grant, a sum of money to construct a multi-purpose playing field on the town owned parcel of land behind the Middle/High School; or take any other action relative thereto.
- To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money to be used by the Parks Facilities Committee for a Needs Assessment/Feasibility Study and other related services necessary for the implementation of the West Boylston Parks Facilities Improvement Program; any funds

not expended or committed to be expended under a contract by October of 2008 shall revert back to the source of funds, or take any other action relative thereto."
